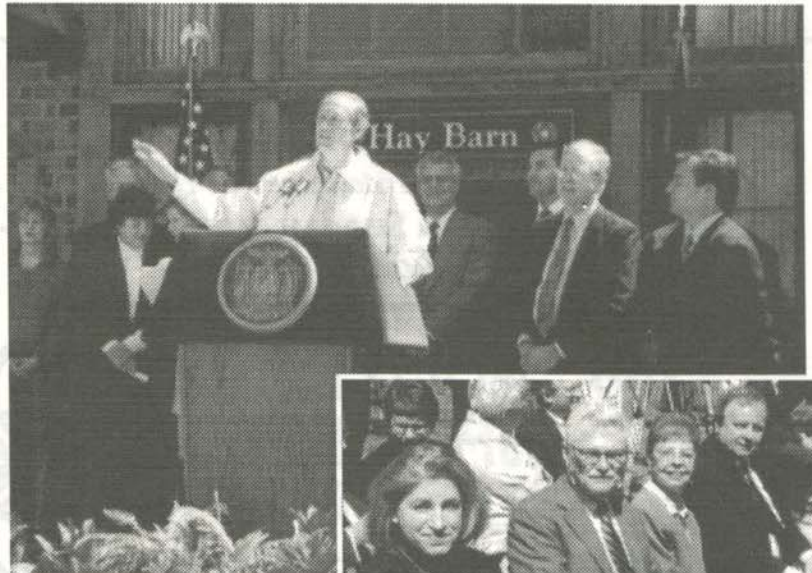

Museum Gets N.Y. State Grant !

*At a special press conference at the Hay Barn at Planting Fields on Friday, April 27, as Commissioner Bernadette Castro, State Senator Carl Marcellino, Glen Cove Mayor Tom Suozzi and other State and local officials looked on, Governor George Pataki announced the 7 Long Island recipients of this year's grant program from the New York State Office of Parks, Recreation and Historic Preservation.
The North Shore Historical Museum was awarded \$105,000.*

On a beautiful Spring Arbor Day, representatives of the Museum - President Brian Mercadante, Vice-President Arthur Finer, Secretary/Treasurer Rhoda Finer and Glen Cove BID Director Francine Ferrante were among the invited guests. The grant is earmarked to assist the completion of the acquisition of the Police/Court House and begin the renovation and restoration of the building.

"After three years of intensive brainstorming and fundraising, we feel that we are now on our way to achieving our first goal - acquisition of the building and its exterior rehabilitation" said President Mercadante. "We are grateful to our loyal and generous members and particularly our hardworking Board members for their continued support and enthusiasm", he added.



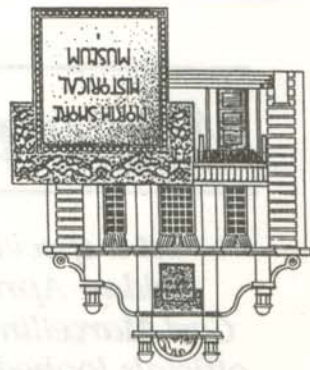

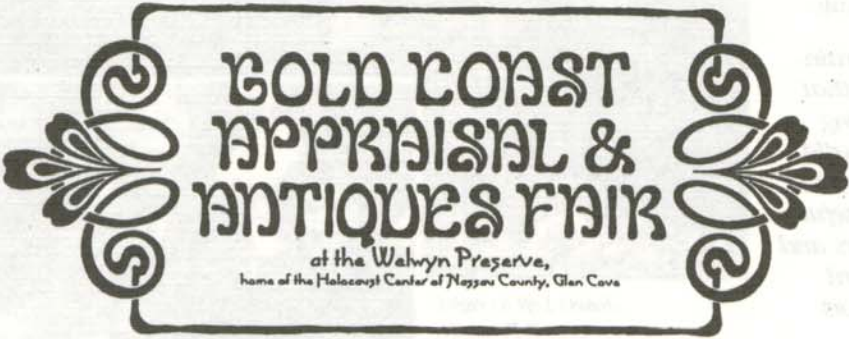
